

SPONSORSHIP OPTIONS

Children in Residential Care
£ 25 per month:

Helps fund the care and education of children in KWTC homes, providing them with safe accommodation, support, food, clothing & everything you would expect from a loving family.

Children in Education Outreach Care Programme
£20 per month:

Helps to provide financial assistance for a child in a very low income family providing the child attends full-time education.

Kings School Bursary
£25 per month:

Provides Bursaries to orphan & homeless children, physically handicapped, hearing & visually impaired children, and children from low income families to attend Kings English School. The Bursary covers the cost of education, clothes, meals & activities.

Medical Outreach Support
£25 per month:

Helps to support children with disabilities from low income families in their own homes and provides the families with any medical aid required.

Higher Education (ages 18-21 years)
£50 per month:

Provides funds for disadvantaged students to attend university, polytechnical colleges, or skills training programmes.
